It consists of twenty-seven members who represent all facets of the criminal justice system: judges, prosecutors, defense attorneys, legislators, victims, law enforcement, treatment specialists, ethnic minorities, corrections, parole authorities, and others. The commission is here to assist you in developing, analyzing and recommending sentencing policy for the State of Utah. PENALTIES AND DEFINITIONS

Class C Misdemeanor

Up to 90 days in jail. Fine of up to \$750

Justice Court Jurisdiction

Class B Misdemeanor

Up to 6 months in jail. Fine of up to \$1000

Class A Misdemeanor

1 year in jail. Fine of up to \$2500

District Court Jurisdiction

Third Degree Felony

0 to 5 years in prison. Fine of up to \$5000

Second Degree Felony

1 to 15 years in prison. Fine of up to \$10,000

First Degree Felony

5 to Life in prison. Fine of up to \$10,000

Capitol Felony

Death, Life without the possibility of parole, 20 to Life

CCO

Grievous Sexual Offense

LWOP

Life Without the Possibility of Parole

SBI

Serious Bodily Injury



EXAMPLES OF SENTENCING ENHANCEMENTS

Offenses Committed in Concert with Two or More Persons (76-3-203.1)

 Penalty is increased by one degree if the trier of fact finds beyond a reasonable doubt that the person acted in concert with two or more persons. (Gang Enhancement)

Use of Dangerous Weapon in Offenses Committed on or about School Premises (76-3-203.2)

Penalty is increased by one degree: First degree felony cannot be suspended

Penalty for Hate Crimes—Civil Rights Violation (76-3-203.3)

 Penalty is increased by one degree for a person who commits any primary offense with the intent to intimidate or terrorize.

Habitual Violent Offender (76-3-203.5)

Penalty is increased by one degree

Offenses Committed by Prisoner (76-3-203.6)

Where a prisoner is serving a sentence for a first degree felony or a capital felony and the
prisoner commits certain felonies, the prisoner shall be sentenced to life in prison without parole or
to 20 years to life.

Body Armor Enhancement (76-3-203.7)

The court may increase the <u>maximum</u> sentence to 20 years for a second degree felony or to 10 years for a third degree felony.

Use of a Dangerous Weapon (76-3-203.8)

- Additional year added to the <u>minimum</u> sentence and up to 5 years added to the <u>maximum</u> sentence.

Previous Conviction for Crime Committed with a Dangerous Weapon (76-3-203.8)

Additional 5 to 10 year sentence to run consecutively.

Repeat and Habitual Sex Offenders (76-3-407)

 The <u>maximum</u> penalty for a sexual offense is increased by 5 years for <u>each</u> conviction of the defendant for a prior sexual offense.

Subsequent Domestic Violence Offenses (77-36-1.1)

 Class C, B, and A misdemeanors are increased by one degree if committed within three years of a previous domestic violence conviction.

DRUG OFFENSES

Sentencing Enhancements

- Enhancement of one penalty degree for subsequent conviction (58-37-8)

Class C Misdemeanor

- Use of imitation controlled substance (58-37b-4)

Class B Misdemeanor

- Possession or use of less than one ounce of marijuana (58-37-8)
- Owner allowing property to be used by persons using controlled substances (58-37-8)
- Catch-all provision (58-37-8)
- Possession, use, or cultivation controlled substances or drug paraphernalia (58-37a-5)
- Distribution crystal iodine (58-37c-19)
- Selling or distributing an iodine matrix (58-37c-19.5)








This graph shows the total number of reported crimes (not rates) compared to the total number of offenders incarcerated in the state prison system.


Index crimes include murder, rape, robbery, aggravated assault, burglary, theft / larceny, motor vehicle theft, and arson.
